WHEREAS, In accordance with resolutions of the 1959 and 1960 National Conventions, the National Executive Committee, through its Program Study Committee, has caused to be made a review of all non-legislative policy resolutions, and such action has been taken in further conference with the action of the 1936 National Convention, which established policy on the life of such resolutions; and

WHEREAS, The Media & Communications Commission has concluded an extensive review of National Executive Committee and National Convention resolutions relating to the Media & Communications Division from 1946 -2009; now, therefore, be it
